TML Health Benefits for 10/1/23-24

Kim Whitsitt addressed Council concerning the renewal of the employee group health, dental, vision, life insurance and disability plans with TML Health Benefits Pool for the 10/1/23-24 term. After further discussion Debra Haehn made the motion to approve the renewal of the plan with Option 1. Option 1 increases the annual deductible to \$3,000.00 with a \$7,000.00 annual out of pocket. Billy Burks seconded the motion. All members present voted "Aye".

Nortex Proxy

Mayor Truette addressed Council concerning proxy/alternate designations for Nortex. TXCDBG 2021 - Funding Overages with Reserve Funds

George Huffman addressed Council concerning the CDBG 21 water line replacement project. George explained the base bid construction estimate of \$653,980 was greater than the grant award of \$350,000. An alternate bid of \$456,050 was also furnished, which would not complete the project. Billy Burks made the motion to approve the full base bid and overages would be funded with water and sewer reserves. Leslie Hash seconded the motion. All members present voted "Aye".

Archer City Ambulance Service - Texas Department of State Health EMS Provider License

George Huffman addressed Council concerning communication received from DSHS about the active Archer City EMS provider license. George stated that "as required by EMS rule if the license remains active and current, the EMS provider will be required to be in compliance with all the requirements of a EMS provider as defined in TAC 157.11". DSHS further stated "if the provider license is

not going to me maintained, you may want to surrender	it back to the department". After further discussion by Council, Billy Burks
made the motion to surrender the license back to DSHS	. Paula Bradley seconded the motion. All members present voted "Aye".
