**NEW BUSINESS**

**Golf Carts and ATV Regulations**

George Huffman addressed Council and Citizens concerning recent complaints of the dangerous and illegal use of golf carts by children and explained golf carts were regulated by the Texas Transportation Code. Numerous citizens present requested Council allow the operation of golf carts in the City and expressed concern over the number of children operating golf carts. Mayor Green stated he supported the use of golf carts within the City by adults. After further discussion the consensus of Council was to table the item and consider an Ordinance at the September meeting to authorize the operation of golf carts by licensed drivers on any street in the City with a speed limit of 35 m.p.h. or less. No action taken.

**Pickup Bid**

George Huffman addressed Council concerning awarding a bid for the purchase of a new maintenance pickup. George stated a bid opening was conducted on August 15, 2016 and the low bid was submitted by Sewell Toyota for a 2017 Toyota Tacoma in the amount of \$22,076.06.
